



MEMORANDUM OF UNDERSTANDING COOPERATION AGREEMENT

by and between

collectively referred to as parties (hereinafter referred to as Parties) undersigned place and date, with the following terms and conditions.







In a mutual desire to promote further intercultural, educational, scientific and technological cooperation, the Parties agree to the following framework of academic cooperation:

- 1. Under this agreement, each institute will endeavor to promote cooperation for mutual benefit by maintaining the following areas:
- 1.1. Promotion of joint research and educational activities;
- 1.2. Invitation for Short-term Visits by Faculty Members and researchers for lectures, conferences, colloques or any other academic activities;
- 1.3. Collaboration on pertinent publications and exchange of information in mutually beneficial fields of Interest between the Parties;
- 1.4. Promotion of students' foreign partial studies and internship for study and research, on the basis of the available scholarships.
 - Other forms of cooperation may be established when the Parties agree separately on each specific case.
- 2. The details concerning the reception of students can be the object of a separate agreement.
- 3. The fields of study are to be designated for each case, based on mutual interests. The conditions for employing the achieved results as well as arrangements for specific visits should be endorsed by both Party on each specific case.
- 4. This agreement does not involve a direct financial commitment by either Party. The Parties understand that all arrangements will depend upon availability of funds, which may be collaboratively and/or separately sought by both Party, as well as by associate sources, which can be brought in.
- 5. Based on this agreement the faculties and institutes of the Parties can draw up joint working schedules.
- 6. This agreement will become effective from the date of the signatures by the representatives of the Parties and valid for the initial period of five years. The agreement will be reviewed not less than six months prior to the natural termination of the current agreement and may be extended or renewed in mutual accordance. At any time, the terms of this Agreement may be amended by mutual agreement in a written notice.

- 7. The agreement may be terminated by either Party with a six-month notice. No applications shall be considered after this notice; however, the Parties will continue to fulfill their obligations with the accepted exchange students until the completion of their study plans.
- 8. According to this agreement, a supervisory and monitoring committee may be formed, comprising the Parties' natural persons, responsible for ensuring the proper implementation of the agreement;
- 8.1. The committee may hold periodic meetings according to an annual program agreed upon in advance;
- 8.2. The representatives of either Party in the committee may be changed, provided that a notification letter is sent to the other Party before the next meeting of the committee is held.
- 9. Regarding matters not regulated by this agreement, the provisions of Hungarian law shall apply. In the case of any legal disputes arising from this agreement, the Parties stipulate the exclusive jurisdiction of Hungarian courts.
- 10. This agreement has been executed in 4 (four) identical original copies, of which 2-2 (two-two) copies belong to the Parties.
- 11. By signing this agreement, all previous agreements are hereby revoked and nullified

Parties have signed this agreement in accordance with their will in all respects.
